

City Council Chamber, City Hall, Tuesday, July 25, 2017

A regular meeting of the Houston City Council was held at 1:30 p.m., Tuesday, July 18, 2017; Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Larry Green, Mike Knox, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; and Randy Zamora, Legal Department; Marta Crinejo Agenda Director and Stella Ortega Agenda Office present. Council Member Steve Le absent on vacation.

At 1:36 p.m. Mayor Turner called the meeting to order and stated they would start the presentation. Council Members Davis, Boykins, Travis, Gallegos, Laster, Green, Knox, Kubosh and Edwards absent.

Council Member Stardig stated that Kendra Willis is an ambitious single mother with a spinal cord injury due to a tragic shooting and she is currently working for Galena Park Independent School District and Pasadena Independent School District where she manages and teaches special needs and general population school age kids grades K-12, she is the proud owner of Sugar Gallery, making an assortment of cakes and pies weekly and for the holidays, her highest accomplishment however is her daughter Kyndall and since her injury, Kendra Willis has had an enormous amount of adversities becoming independent, raising her daughter and pursuing financial freedom, remaining resilient through it all and she has been accompanying her daughter across the country as she competed in dance and cheer competitions and large on stage productions and Kendra Willis' future goals are to become a motivational speaker and publish a book, sharing her evolutionary expertise with her peers, as Ms. Wheelchair Texas 2017, Kendra Willis' duties are numerous, each year, she has the opportunity to travel, make public appearances and conduct radio, print and television interviews in the fulfillment of her responsibilities and these include promoting awareness of the need to eliminate architectural and attitudinal barriers, educating Texans on disability issues and informing the public of the achievements of people with disabilities across our great state and on July 25, 2017, Kendra Willis will be honored for her many outstanding achievements and the City of Houston commends Kendra Willis for her dedication and commitment to educating and spreading awareness regarding disability issues and extends best wishes for continued success and therefore, Mayor Turner hereby proclaimed July 25, 2017, as Kendra Willis Day Ms. Wheelchair Texas 2017 in Houston, Texas. Council Members Travis, Gallegos, Laster and Edwards absent.

Council Member Cohen stated that the Meyerland Area is found on both sides of Brays Bayou at the southwest corner of Loop 610 and its many neighborhoods include Meyerland, Marilyn Estates, Barkley Square and Maplewood. Many institutions of Houston's Jewish community are found here, including several temples and the Jewish Community Center and the northeast corner of the community includes the redeveloped Meyerland Center retail development and the area was developed beginning in the 1950s. Recently, a deteriorated apartment complex was torn down for the construction of new luxury homes, reflecting the continued high demand for homes in the area, a Super Neighborhood is a forum where residents and stakeholders can collaborate on neighborhood issues and work with city officials to be more responsive to community needs. The people of Meyerland are currently working to formalize the Greater Meyerland Super Neighborhood #31 to be officially recognized by the City of Houston and on July 25, 2017, the City of Houston will formally recognize Greater Meyerland Super Neighborhood #31. The City of Houston commends all those involved in the Greater Meyerland Super Neighborhood #31, especially Harrold Harris, Alan Lipman, Kay Swint and Barbara Marcus, and extends best wishes for continued success and therefore, Mayor Turner hereby proclaimed July 25, 2017, as Greater Meyerland Day Super Neighborhood #31 in Houston, Texas. Council Member Travis absent.

Mayor Turner stated that he takes great pleasure in presenting this special certificate of Graduation for the Minority Women, Small, and Disadvantaged Business Enterprise Program to 3 of the 4 partners of McConnell & Jones LLP, Mr. Ira Wayne McConnell, Mr. Thomas Jones Jr. and Ms. Sharon Murphy and Mr. Odysseus Lanier could not be here today, certified as a MBE in July of 2003 McConnell & Jones LLP has reached a remarkable milestone and officially graduated from the City MWBE program effective May 6, 2017 and during these 14 years as MBE McConnell & Jones LLP had been awarded a total of 9 City of Houston contracts, one as the certified Prime Contractor and 7 as MBE Sub Contractor, the firm has received over \$5,250,000.00 in subcontracting opportunities and as of now graduating MWBE Program and graduation on a job well done and in recognition of their successful graduation from the City of Houston for the Minority Women, Small, and Disadvantaged Business Enterprise Program, this special City of Houston Diploma to McConnell & Jones LLP issued on this 25th day in July of 2017. Council Members Davis and Cisneros absent.

At 2:09 p.m. Mayor Turner recognized Council Member Kubosh for the invocation and he invited Pastor Arnie Casais to offer the invocation and Council Member Kubosh led the Pledge of Allegiance.

At 2:13 p.m. the Roll was called. Council Member Steve Le on vacation.

Council Member Cohen moved to adopted the minutes for June 27-28, 2017 and to postpone adoption of the balance of the minutes and seconded by Council Member Knox, all voting aye, nays none. **MOTION ADOPTED**

Mayor Turner recognized Council Member Boykins for a point of personal privilege; Council Member Boykins stated that last night there was a very disturbing story where Ms. Scott a 91 year old lady, a Senior in the South Park area which is in District D was evicted from her home and the Constables Office was doing what they are paid to do, it was a disturbing site they were taking her furniture out of her house and placing it on the curb and he received a call and they went to the scene trying to move forward to make a compromise, the update that he wanted to give was that they were given some Angels that came to the rescue to help address this issue, a lot of people called the City of Houston and volunteered but this one particular person has come and put in time and effort and assembled a group of people including donors from stores and a hotel put her up, gave food for her, clothes for her and it was a bad situation but it is turning positive and he wanted the City of Houston to know that they are working it out and this young lady is Rene Jefferson which he had never met before she had just turned this negative issue into a positive one and he wanted to publicly thank her.

Council Member Kubosh moved to suspend the rules to hear Ms. Tomaro Bell out of order and seconded by Council Member Laster, all voting aye, nays none. Council Members Stardig and Green absent. **MOTION 2017-0468 ADOPTED**

At 2:17 p.m. Mayor Turner requested the City Secretary to call the List of Speakers.

Mr. Rod Smith, 21 Waugh Dr., 77007, (713)629-7080 appeared and stated that he is a business owner, property owner in this wonder City that he truly loves, he had never been involved in City Politics up until now but when he caught wind of the 15-year Recycling proposal, he had to get involved and step up to help stop this bad deal and he thought he could help since he had been in the trash collection and recycling business in the past 12 years but since Mayor Turner had a change of heart that they do not visit this for now, however, since the sudden change of last Friday, now they have a greater opportunity in front of them to consider and that is to privatize the entire Waste Collection and the Recycling that the City currently is performing and save the

citizens some really money and one thing that he had learned in the past when he was in business and worked for the big trash hollers is that government should no be in the trash collection and recycling business and when he was in the business many people may know that there is not secret when private industry takes over trash collection and recycling there is at least a 25% saving to the tax payers and the citizens of this City deserve the best possible deal and the timing could never be better than now and the administration before them, they have left you guys some really prizes, they all know about the 5 billion dollar pension that Mayor Turner gets to deal with and the one that he really loves is the Astrodome that was open in 1965 and that they still owe 30 million dollars and 2 million dollars to maintain it;

Mayor Turner advised Mr. Smith that Harris County owns the Astrodome.

Mr. Smith further stated that they sold the Astrodome as the 8th Wonder of the World and he wondered who got rich on that deal and the City cannot afford anymore bad deals, they need to securitize everything now and what they been doing and what they are doing in the future. Council Member Green and Robinson absent.

Members of Council questioned Mr. Smith.

Ms. Tomaro Bell, 3248 Charleston St., 77021, (713)825-8449 appeared and stated that on Friday the 14th, she received a text from the Solid Waste Department asking them to come last Tuesday to speak in support of the Recycling Contract and she did not reply and they called her on Monday and asked her if she was going and she really did not know anything or vetted it and she does not come to support Items she does not know but since they called her, she stated that she would be there on Wednesday because she wanted to learn a little more about it and she came here last Wednesday and she concurs with Council Member Christie and was one of the best Council Meeting she been to in years, she applauds all the Council Members but team reflects leadership and she applauds the Mayor and as rare as it is, when she speaks about process she wants the same people that looked at it to look at this process because she learned way more she needed to know about the process and she is quite concerned about the PWE Director, the Capital Improvement Bond Project and what they are asking for falls under PWE. Council Member Green absent.

Members of Council questioned Ms. Bell.

Mayor Turner stated that the Director is on Administrative Leave and he thinks in all fairness and candor, he would appreciate it if she would give the administration the opportunity to investigate it before in public chastising him when he is on Administrative Leave and he thinks everyone deserve that.

Ms. Ada Edwards, 1033 Theresa St., 77051, (713)501-3786 had reserved time to speak but was not present when her name was called. Council Member Green absent.

Mr. Daniel Hernandez, 7342 Lamar, 77011, (713)923-4790 appeared and stated and ask that they excuse his voice as he is having an issue with Cancer, he wants to rent a property and about 8 months ago his tenant moved out of the apartment and he started to make some minor's repairs and couple weeks later a City Inspector came to inspect the property and he got some violation sticker and in his opinion since he was not doing anything that required an inspector he did not pay attention to it and 2 weeks later he put on another one, 2 weeks later another one and 2 weeks for 4 tickets and he called him after the fourth one and he told him that he would have to pay a \$250 fine for each violation he put on his property and he wonders what he wanted on the fourth one to call him and tell him that he had to pay such a fine and in the past he had problems

with Inspectors and in 2011, he pulled out all the permits he need for his business and even after he had done all the requirements the City Inspector came out with telling him he needed another permit, he had to call his Council Member and he had to speak with the top Supervisor and it turned out that he did not need that permit, they were trying just to get money from him, in regards to the garage apartment he must acknowledge that he ended up doing more than the electrical part than he thought and he had been talking to a Mr. Kevin and he told him that he would have to pull a permit for electrical which he is willing to do and he just here asking them to not to ask him to get more permits that he needs for the job that he had been doing and 4 years ago he replaced a couple of pieces of plywood and 5 years ago he replace a couple of boards on the siding and the City Inspector also put stickers on his property and in his opinion replacing couple of pieces of plywood or siding does not require a City Permit. Council Member Green absent.

Mayor Turner questioned Mr. Hernandez about the inspector coming out and citing him on failing to have 3 permits and then you are saying the permits were unnecessary and he requested that Gary Norman with PWE to speak with Mr. Hernandez and to check and make sure what they are asking is unreasonable and to make sure it is consistent on what the requirements are.

Mr. John Branch, 4430 Castor, 77022, (310)710-4181 appeared and stated that he was Community Development Commissioners for 10 years for the City of Houston and when they had a Community Development Commissioners they decided where the money would go for community development in their communities and he fought very hard for the 2.5 million for the Independent Heights Police Store Front and that money was earmarked for Independent Heights and that is where the money should stay and he already knows what they Mayor is going to say, 10 years ago, they fought and asked for the old Fire Station to be a Community Center and it was sold and he knows that he was not the Mayor, for the past 6 to 8 months they have been asking for the Independence Heights Store Front to be a Community Center and he told them he got them and everytime the Mayor saw him, he would tell him "I got you" that he had been knowing him for a long time, and they came for one item and that is the Police Store Front as a Community Center, he knows how Politics work, they have the recommendation on how and what they were going to use it for, what the utilities they would going to pay and all the Mayor had to do is pick up the phone and say it is a done deal and give it to them, he never did and week ago he discovered that the independence Heights Police Store Front was being put up for sale, 2.5 Million dollars was invested into that property and if it is sold is it going back to the General Budget or is that money earmarked for Independence Heights. Council Members Davis and Green absent.

Upon question by Mayor Turner and Mr. Branch advised that is what his Council Member is saying is that it is up for sale and all indications that it will be on the Agenda next week to be sold,

Mayor Turner advised him that he had to take a look at it and he also stated that before he be leaves and had been told that the City does not own the property and they are checking on it and that it is owned by Weingarten, it is not own by the City of Houston.

Council Member Cisneros stated that what she had read and received from GSD is that HPD declared the reference property surplus and is seeking Council Approval to consider 803 Crosstimbers to is the City's needs and available for sale.

Ms. Edna Douadi, 10902 Roark Dr., 77099, (713)412-4002 appeared and presented information stated that she is with Globe Electric Supply company and she represents a small minority company, she had been a City of Houston Vendor since 1976 and she is here to address 4 points which she disturbed to everyone the information and sent everyone an e-mail, one, is that she request for previous Administration to post the informal bids that are under \$25,000.00 online and the City had been giving her excuses like they are looking for new software, second, the City OBO

Department putting goals or lack thereof on City bids on the supply bids, and currently what they have is a sub-contracting opportunity that only applies to construction in the supply sector and in the supply business there is no sub-contracting opportunity, third, she was asking the OBO Department to put more goals and not to allow or give waves to large Manufactures who prefer to be direct and the last thing she was asking for the City about the Hire Houston First because the previous Administration promised her to do local preferences which does help small companies and she does not thinks its fair and really applies and she also wants them implement discretionary bids or set a side bids for small companies to only participate only. Council Member Davis, Martin, Cisneros, Laster, Green, Knox, Kubosh and Christie absent.

Ms. Debbie Sieck, 12727 Huntingwick, 77024, (713)385-5249 appeared and stated that she just wanted a chance to come before them so that they can see her, she works at a school and is unable to make the meetings most of the time, she loves her home and its her biggest investment and she worked at a high school as a Counselor for the last 17 years, she brought her townhome right after she got divorced and she chose it because it was the most affordable thing in the best area and at the time of the purchase the complex and it never had flooded and the reputation for being well cared for, the first flood happened in 2009 and they said it was a freak of nature, she did not have flood insurance because she was not in a flood plain and she was forced to take out a home improvement loan to do the reconstruction and on a side note she made her final payment on that loan on July of 2016 after her third flood, she flooded again on Memorial Day Flood and the Tax day Flood and she did have flood insurance for both of those and the stories of bad contractors, time away from work and everytime it rains she gets scared and presented pictures which she has all of her furniture on bed risers and she decided after the third flood she was going to try to sale her townhome which is beautiful she might add because she spent time and energy in making it beautiful and she did not have one offer and people do not want to buy property that had flooded three times as a result of this, 3 units in her townhome complex are empty or leasing and none of them are leasing, the townhome directly in front of her is in foreclosure because the people just walked away and this effects everyone she know and it is effecting her job as a Counselor and she is here to really ask for their help, she attends all the Flood Meetings and all the TIRZ Meetings and asked them to consider them. Council Members Davis, Boykins, Martin, Laster, Green, Knox and Kubosh absent.

Members of Council questioned Ms. Sieck at length.

Mayor Turner stated that he appreciates her being here and he is open to any of the Council Members with any suggestions on where they can come up with the additional dollars.

Mr. Zafar(Zaf) Tahir, 16 Shadow Ln., 77080, (713)504-0156 appeared and stated that he came he, to thank the Council for their actions portraying Houston as a World Class City and he stands here as a proud Founder Member of Islamic Art Society and advocates on their behalf, Arts in Islamic Worlds and City of Houston, under the shining example of how the City is at the forefront of not just in the Western World but the entire World and as the City that is proud of the multifaith and multicultural environment and in Houston they just do not associate national original ethical art but they go beyond and they challenge the foundation on which they stand on their traditions, arts, culture, languages, they include them in their fold and give them space in their corridors and listen to their history and able to see their inhibitions, their fears, their visions and their future plans simply by looking at their paintings and in this City they just tolerate the cultural, they respect them, they just do not talk about diversity, they practice them and in the word from the Mayor, “ We do not Build walls, we build relationships” and what a powerful statement that he witness first hand when he visited the Mayor as a delegate to the UK and Germany, it's a very powerful statement, he is not artist but the exhibits in City Hall that are there today speaks volumes about

the mindset for this City but this support that they are showing in City Hall is above and beyond their expectations, they want to thank all of the City Employees that helped them and he especially thanked a list of people because they have worked very hard to bring this exhibitions to City Hall and today they will have a reception at 5:00 o'clock and they would like to see all the Council Members there because this is a wonderful opportunity to showcase Houston and good for the environment. Council Members Davis, Martin, Travis and Laster absent.

Members of Council questioned and thanked Mr. Tahir.

Dr. Khawaja Azimuddin, 51 Manor Lake Estates Dr., Spring, TX, 77379, (832)457-0740 appeared and stated that he is a surgeon and his passion is Arts and on behalf of the Islamic of Arts Society he would like to thank the Mayor and the Council Members for the opportunity to speak in front of this Council today, the Islamic Arts Society means to share the rich heritage of arts in Islam, over 200,000 people of the Muslim Origin live in the greater Houston area, they organized events to celebrate their culture and to promote the positive image of the Muslim Community among Houstonians, Art is a universal language and helps build bridges and promoting Islamic Arts they are inspiring to promote mutual understanding and to broaden the Houston Community together, the Islamic Arts Society organizes exhibitions in schools, museum and galleries, they do art classes, live art demonstrations that are very popular among the audience and they attract large crowds of people, their flagship is the Islamic of Arts Festival in the fall every year that attract over 5,000 people and it brings people together with diverse backgrounds, faith and cultures for a fun, festive and education day, the Islamic of Arts Society is grateful for the opportunity to display their Art in City Hall and they are thankful that the Mayor is going to preside over the ceremony at 5:00 p.m. in the Legacy Room and some of the Art that they will see, will be by 40 people from the local areas that have a passion for the Islamic Arts and he welcomes all Council Members and everyone that is present to join them in the ceremony. Council Members Davis, Boykins, Martin, Travis, Green, Knox and Edwards absent.

Mr. Steven Williams, no address, no phone, had reserved time to speak but was not present when his name was called. Council Members Davis, Boykins, Martin, Travis, Green, Knox and Edwards absent.

Mr. Joshua Bullard, 3328 McGowen St., 77004, (832)258-7511 appeared and stated that he wanted to share something with the Mayor which he had spoken to his predecessors about over the years, between he and the Mayor it had always been political but it had never been personal because he like the Mayor and he knows that he told everyone that he is a millionaire and that was only because he told everyone first back in the 90s when he ran on the Multimillion dollar platform, he was just following his lead and the point is that he had been trying to get a meeting with him for almost 2 years and that is 2 years too long and they need the Taxi business in Houston to be an open entry system and they need the rates to be lowered and he knows that a lot of taxi drivers do not want that and he would not lead the Mayor in a wrong direction and he really needs him to move forward with an Executive Order to Open Entry the Taxi System and let Council vote on bring the rates down, so that Seniors can get service. Council Members Davis, Boykins, Travis, Laster, Green, Knox and Edwards absent.

Mr. Byron Thomas, 11514 Sandstone Canyon Dr., Humble, TX, 77396, (713)299-7798 appeared and presented information and stated that he is a United States Veteran and he currently works for the Michael Deakey VA Medical Center, he is here to address the do not rehire letter in his professional file, he was fired by the last Administration after 10 years of service with the City of Houston, they wove of web of deceit concerning his firing and in the information provided is a history of what happen but at the end of the day he was fired for incomplete conviction on his

initial application and they went back 10 years because they could not really fire him for selling City Property but that is what the do not hire list is and that is what the letter says which is untrue and why he is here he just wants that letter to be removed so he can move forward with his life and he lost everything because of the action that they took, he is still recovering and he was not where he was, not where he wants to be but he is alright and he is requesting for them to take that do not rehire letter out of his file. Council Members Davis, Boykins, Travis, Cisneros, Laster, Green and Edwards absent.

Mayor Turner stated that they would take a look at it.

Mr. Sebastian Osudke, 7143 Osage St., 77036, (713)366-6829 appeared and stated the issue that he is faced right now whether that he is human, is he a human being, should he be protected by the same laws that protects others and the issue is yes and he is requesting for Council Members to send help to send a Inspector to his house because he lives in a place where his landlord bullies him, he lives in a place where his landlord does not think he is human, he presented pictures of his landlord that bullies him, presented a picture on where he lives and if they go to his house now they would see flies, smell rotten stuff, there are no light in his bedroom and his kids do not have light in their room, then he presented items that are peeling off in his house that does not cost that much and then showed a picture of his landlord and how he fixes things around the house, when there is no water and the water is leaking, his landlord will go to the main city water pipeline to attach it off and that is how he fixes his house but he cannot get a Health Inspector from the City to his house because this is a crime and then presented pictures of himself fixing his fence. Council Members Davis, Boykins, Cisneros, Green and Edwards absent.

Mayor Turner questioned Mr. Osudke and advised if he was in a Section 8 Housing that he got from the Houston Housing Authority and was advised that he was right about the House in Section 8 and he wanted the landlord to make the necessary repairs to the home and he asked him what his payments were per month and Mayor Turner asked who is handle this and Rene with the Mayor's Citizen Assistance Department advised that they responded with the landlord and the tenant have both responsibilities with the up keep of house and there was an Inspector that was supposed to come out yesterday to come and investigate the situation.

Mayor Turner stated further stated when the response says that they both have responsibilities that is like saying that is non-starter because it does not work, if the house is refer through the Housing Authority they have to assume a greater role in it, they just cannot pass it and asked them to make direct contact with the Houston Housing Authority, they need to go out and take a look at this and they need to assign responsibility.

Mr. Emmanuel Thomas, 702 Weber, 77090, (832)931-1469 appeared and stated that he spoke to Mayor Turner on a Sunday morning live show a few months ago and he reassured him that the New Chief Acevedo would be coming out and helping out with the crimes in the community and right now he wants to give the accommodation and he has a lot of respect because he had done that, he had seen him on numerous occasions out there at the scenes and he also wanted to tell the Mayor that he had done a lot for many years and he knows that he will not make everyone happy and to continue doing what he is doing, the other thing that they are asking for is to help them out in the Greenspoint area, to do some activities at their parks or community patrols, they need some help with the sidewalks. Council Members Davis, Boykins, Laster and Green absent.

Members of Council questioned Mr. Thomas.

Ms. Renee Green, no address, (713)416-7295 appeared and stated that it saddens her that she has to come down here to speak, for years she had asked the Police Department to come to her home because of vandalism and mischief and she had even come to the Mayor's Office and spoke with his staff and since then her home was foreclosed on and again she reached out to the City for help with no one came to help her, she had to move her stuff into storage because she could not find a place she liked and could afford and recently she moved in Senior Independent Living Apartments Complex and recently she tried to move her furniture out of storage, she was so surprised in a month time the rates that she was quoted was crazy, outrageous, for 2 hours it was like \$200 something dollars, hourly rate \$100 something dollars and she cannot afford that when only month and half ago their rates were \$39.00 and she wants to know if there is any regulation on these moving companies and how they are allowed to get away with this robbery and she only had a few days to get it out and she needs help. Council Members Davis, Boykins, Laster and Green absent.

Mayor Turner and Council Members Robinson questioned Ms. Green.

Mr. James Partsh-Galvan, 2705 Terry St., 77009, (713)528-2607 had reserved time to speak but was not present when his name was called. Council Members Davis, Boykins, Laster and Green absent.

Mr. Craig Brown, no address, (346)314-1616 appeared and stated that he lives in the 290 and Tidwell area and he stays at extended stay hotel, they have been robbed 3 times in 8 months by gun point and more activity and they have security and he just needs help, he does what he can, he even walks the parking lots at night to try to help and 2 workers from that hotel were put to the ground at gun point at 2:30 in the afternoon, he needs help and these people are like family to him and he feels like he needs to say something and whatever they can do please help him. Council Members Davis, Boykins, Martin, and Green absent.

Council Member Stardig questioned Mr. Brown.

Ms. Arveyiel Fortilla, 1110 Sydnor, 77020, (832)817-9132 had reserved time to speak but was not present when her name was called. Council Members Davis, Boykins, Martin, and Green absent.

Mr. Roberto Varela, 5959 Guhn Rd., 77040, (713)299-7226 appeared and stated that Mr. Brown already said that need to be said regarding that area which is a very high crime, he been working there for a year and the only thing he had not seen is the Police reaching out on the business community and he understand that there is a budget to follow and he wants the Police to reach out to the business community because it would help the crime decrease and he understands that crime is everywhere but in that area they been robbed at gun point within 9 months, three times and his employees do not want to come to work anymore. Council Members Davis, Boykins, Martin and Green absent.

Mayor Turner and Members of Council questioned Mr. Varela.

President Joseph Charles, Post Office Box 524373, 77052-4373, Houston, TX, appeared and requested more time and stated his subject was absolute Marshal Law, Salaries, Revoked, H/City, Texas/State, and Government Systems and continued to voice his personal experiences. Council Members Davis, Boykins, Martin and Green absent.

MAYOR'S REPORT

Mayor Turner invited Juliet Stipeche and Jane Cheeks to the podium and stated that they led the Hire Houston Youth program and Ms. Stipeche presented a power point report by the Mayor's Office of Education to Members of Council of the Hire Houston Youth and requested all the Interns for this Summer Program to stand to be recognized.

Members of Council questioned Ms. Stipeche and Ms. Cheeks.

Mayor Turner further stated that the goal is to number one is to provide an opportunity for every kid in this City that desires to work during the summer and the reality from this program there are kids that are coming from outside of the City, there are kids that come as far out as Galveston or Montgomery County that are participating in this program and number two, the goal will always be to make this program reflective of our communities and to extend their reach as broadly as they can and to reach every person in every community in every neighborhood that desires a summer job and he thanked the whole team for their commitment and dedication and passion to the Program.

Mayor Turner stated that he wanted to turn to this final item and he will make it brief but it is important in view what happen in San Antonio a few days ago, he wanted to make a brief report as it relates to human trafficking and human smuggling and what happen in San Antonio was truly tragic and he knows that Minal Patel Davis is here today along with people with the HPD and he invited them to the podium and just in case Members of Council have any questions; in 2017, HPD reports 109 cases in Human Trafficking charged, 36 in which there was compelling prostitution charges and in the prior year there were 155 Human Trafficking case charged, 72 of which were compelling prostitution charges; in the 2017 up till today HPD reports that there were 9 cases of Human Smuggling charges and in the prior year there were zero Human Smuggling cases that were charges, unlike smuggling, Trafficking victims can be U.S. citizens, they do not need to be transported across a political border and the crime is one of exploitation, not consent; despite what the term implies, Trafficking do not require movement, Trafficking victims does not consent to being sold for a commercial sex or labor act and that distinction needs to be drawn today and regardless of smuggling or trafficking, the events themselves are horrible and the results can be the loss of life in both and in both they are certainly unacceptable and they should do everything they can to prevent and he wanted to provide at least that information and he is sure what people wanted to know the activity in the City of Houston to this date.

Members of Council questioned representations from the Houston Police Department.

The Finance Department reports that \$52.5 million of that amount was from FY 2016. The revenue from SPAs now represents 8.2 percent of the sales tax collection for the City.

This is the first of two required public hearings. The second public hearing is scheduled for August 2nd. Following the second public hearing, the Planning Department will be seeking Council approval for the SPA and the limited purpose annexation on August 23rd, 2017. If approved, tax collections will begin on January 1st, 2018.

For the Utility District included in this hearing, Kingsbridge MUD, the city will levy a 1 percent sales tax, which it will divide evenly with the District. The area includes commercial territory only: A Home Depot and a Whataburger outlet. There are no residents in the area to be annexed.

For this MUD, the City will amend an existing agreement by adding new territory. There is no territory outside the MUD to be included in the annexation.

That completes my report, I'm happy to take questions at this time.
