City Council Chamber, City Hall, Tuesday, August 28, 2018

A regular meeting of the Houston City Council was held at 1:30 p.m., Tuesday, August 28, 2018; Mayor Sylvester Turner presiding with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Martha Castex-Tatum, Mike Knox, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Randy Zamora, Legal Department, Marta Crinejo, Agenda Director and Stella Ortega, Agenda Office present.

At 1:57 p.m. Mayor Turner called the meeting to order and stated they would start with the presentations. Council Members Davis, Boykins, Martin, Le, Gallegos, Laster, Knox, Robinson, Edwards and Christie absent. **NO QUORUM**

Council Member Cisneros stated that the Houston area is wonderfully enriched by dedicated individuals who are willing to serve the public in all sectors, through tireless personal service and leadership, professionals work daily to improve the quality of life for all and Paul J. Puente has spent years advocating for pre-apprenticeship training courses to introduce career opportunities in pipefitting, electrical work, plumbing, and other skilled construction work in an effort to expand the number of skilled construction workers and as the executive secretary of the Houston Gulf Coast Building and Construction Trades Council, his advocacy and leadership helped create a partnership between the City of Houston, the Houston Contractors Association and the Houston Gulf Coast Building & Construction Trades Council to further the goal of strengthening the workforce through Apprenticeship Readiness Programs and Paul J. Puente is a delegate for the Houston Construction Industry Council and a member of the Houston Business Roundtable, the Greater Houston Partnership, as well as board member of Houston First Corporation and numerous other business organizations, he is currently a council member for Texas Governor Greg Abbott in both The Texas Workforce Investment Council and The Apprenticeship and Training Advisory Committees and on August 28, 2018, Paul J. Puente will be honored for his work, leadership, advocacy for the building trades and for enhancing our community. The City of Houston commends Paul J. Puente on his accomplishments and extends best wishes on all future endeavors and therefore, Mayor Turner hereby proclaimed August 28, 2018, as Paul J. Puente Day in Houston, Texas. Council Members Boykins, Martin, Le, Gallegos, Laster, Kubosh and Robinson absent.

Council Member Travis joined by Council Member Davis stated that the Post Oak Little League began as a little league organization 62 years ago offering baseball practice and competition for boys ages eight through 12 and the league currently operates through a lease and partnership agreement with T.H. Rogers School and the Houston Independent School District and this season, Post Oak Little League represented the Southwest Region and had 750 players and 63 teams with 10 teams in the majors' division from which all-star players are selected and this season's all-star team is the first 12-year old Post Oak Little League team in the history of the organization to make it to the Little League World Series, the Post Oak Little League all-star team enjoyed phenomenal wins in the District 16 Tournament, the Section 3 Tournament, the Texas East State Tournament and the Southwest Region Tournament championship game and on August 28, 2018, Post Oak Little League team will be recognized for their outstanding achievements. The City of Houston commends and congratulates Post Oak Little League team for its diligence, solid sportsmanship and tremendous efforts and extends best wishes on their continued success and all players were introduced and therefore, Mayor Turner hereby

proclaimed August 28, 2018, as Post Oak Little League Day in Houston, Texas. Council Members Boykins and Gallegos absent.

Council Member Cohen stated that the third presentation will be given to Mayor Turner and that is all she going to say and introduced Jamey Rootes.

Jamey Rootes stated that he is the President of the Houston Texans, Mayor Turner and Members of Council and he has a very simple message for them, football is the ultimate team sport and the team does not just mean the guys on the field, it means the leadership of the City, the fans and the message that he wants to deliver to them is thank them for the amazing support, it has created something very special and what the Mayor likes to say and he does too, is that Houston is a very diverse City in America, on the weekdays they go through their lives as individuals but on Sunday we all come together as one because we are Texans and nothing brings us together like football and when they started the team, they had 3 imperatives, one is to win the Championship, the second one is about memorable experiences and the third imperative which is most proud of is doing great things for the City of Houston, here on the Anniversary of Hurricane Harvey reminded that JJ Watt, the Houston Texans, the NFL, raised over \$50 million dollars for Hurricane recovery and relief along the Gulf Coast, they are delivering their Community Impact Report which includes a lot of their community involvement and he wanted to thank them for being part of their partners for the City of Houston and also presented Members of Council with cookies. Council Members Davis, Travis and Gallegos absent.

Mayor Turner stated that Jamey is the Former Chair of the Houston Partnership and the President of the Houston Texans and he is out here making things happen everyday, leading charge, and they cannot thank the Texans enough and thanked the McNairs for the contributions that they have made and continue to make and they are looking forward to the new season with the Houston Texans which he echoes what Jamey said early, that there are not just players on the field but there are players inside the community as well and they are very grateful and looking forward to this new season.

At 2:34 p.m. Mayor Turner recognized Council Member Knox for the Invocation and Pledge and he invited Pastor Tom Douthit for the Invocation and Council Member Knox led the Pledge of Allegiance. Council Members Davis, Travis and Gallegos absent.

At 2:39 p.m. The Roll was Called. Council Member Travis absent.

Council Member Cohen moved to adopt the Minutes of May 22-23, 2018 and delay the balance and seconded by Council Member Robinson, all voting aye, nays none. Council Members Davis, Martin, Travis and Knox absent. **MOTION ADOPTED**

Mayor Turner requested the City Secretary to call the List of Speakers.

Anne Whitlock, 317 Sampson St., 77003, (713)303-2760 had reserved time to speak but was not present when her name was called. Council Members Martin, Travis and Christie absent.

Yvonne Green, no address, (713)703-5642 appeared and stated she is supporting the complete communities initiative and together they can help communities design their own Complete Community according to the needs of the community and she is proud to be a Member of Acres Homes Community and serve on the Complete Community Economy and Workforce Committee, along with others on the Community and one is opening a Community Coffee shop that is run by Community Members and to say that she supports Item 7 the Complete Communities Action Plan for Acres Homes and this is a safer and less costly option in their communities where there is not

enough banks in the Community and that this is accessible to everyone and not just for low in individuals and in today's consumerism society, families need access to services such as united way job funding and coaching and other nonprofit resources that may provide a strong support system to encourage habits of savings as they become financially strong and closing collaborations and partnerships are key to completing all this work and she is proud to in the Acres Homes Community and their complete Community Action Plan. Council Members Martin, Travis and Christie absent.

Members of Council questioned Ms. Green.

Ruby Glass, 1059 Mansfield, 77091, (832)292-0609 appeared and stated that the Acres Home Complete Community Action Initiative has become a driving force for change in Acres homes and have brought back together relationships that have been dormant for many years and also inspired a new dynamic that has sparked a positive energy of multigenerational activism something that they have not seen since 1970s a chance to bring local business owners and stakeholders together with the purpose of persevering the history but making room for the new and bring life and new inspiration to a community that deserves to live, grow and matter to those who seek live life and love the land that God gave them and to take care of it for future generations. Council Members Martin, Travis and Knox absent.

Members of Council questioned Ms. Glass.

John Rentz, 720 North Post Oak Rd., Suite 500, 77024, (713)777-7369 appeared and presented information and stated that he is here on behalf of the Houston Real Estate Council which the Memberships are made up as of people in Houston that develop, build and own real estate and commercial properties and he is here to speak about some proposes that are made by City Staff of Chapter 9 of the infrastructure Design Manual and their ability to continue to build these great facilities and building that serve the City and they submitted a Matrix of comments and then he had a chance to look through those updated proposal and this letter today is what they came up with to continue concerns with the proposed language like accommodating sheet flow from another property or even accepting another developed properties sheet flow and the language is unclear if they add to their detention, that needs to be tighten up and clarified, another concern from the Members is the definition of a Disturbed Area is too broad and results in an obligation to provide detention for a temporary construction staging area that will become pervious after construction and a lot of their Members were involved in the Rebuild Houston and supported that program and the fees that are associated with it that would retain their credit for impervious cover for their development in the future and the this language implies that might not be the case and they think that needs to be looked at it little more. Council Members Cohen, Boykins, Martin, Gallegos and Laster absent.

Mayor Turner stated that before he goes to the Council Members, he wanted a good understanding because he read the letter and on the differentiation between Commercial property and residential is that they treat residential property different from commercial property to industrial properties in a number of ways from the electricity side and do not treat residential like commercial, with water they do not treat them the same and if you do treat the residential and commercial on the same context it is impractical.

Members of Council questioned Mr. Rentz at length.

Lois Meyers, no address, no phone, appeared and stated that she is here today to advocate very strongly that Item 34 resolution that they are going to vote on for tomorrow and request that they postpone it and it would be to the high standards of the Walter P Moore Engineering Firm who

directed TIRZ 17 first engineering study and she presented a study to Members of Council and her request that the City raised their standards for all over Houston not just in TIRZ 17 because she had been flooded 3 times in a no floodplain zone that never flooded before and her statement and she believes that the should go to the Army Corps of Engineering to do the study and also their response to her will be heard National, the U.S. Congress will be listening and if they sit there and don't do anything that will speak volumes and she wants to get the support to at least table this resolution. Council Members Davis, Boykins, Martin, Gallegos and Laster absent.

Mayor Turner stated to Ms. Myers that she should be in mind that it was the Army Corps of Engineers that released that water in the wee hours in the night which caused thousands of homes to be flooded but he does understand what she means and Members of Council questioned Ms. Myers.

Clair Kimpel, 806 Thornvine Ln., 77079, (713)240-8716 had reserved time to speak but was not present when her name was called. Council Members Davis, Boykins, Martin, Gallegos and Laster absent.

Roy Grant, 8009 Carolwood Dr., 77028, (832)322-7504 appeared and stated that he is a Member of the Texas Organization Project, retired, United Veteran and he also a community leader, the first day of school started yesterday and he is concerned with the conditions of North East Houston after the one year anniversary with Hurricane Harvey, the Lakewood Library is still not there, so the students in his community have nowhere to study for school, their sidewalks are falling apart and the hurricane worsened their condition in their neighborhood and they have not yet seen an improvements, what is their plan to address these concerns. Council Members Davis, Martin, Le, Gallegos, Laster and Knox absent.

Mayor Turner stated to Mr. Grant that he was out in the Kashmere Garden area on Saturday and they will be continue to go back there in that area because they recognized that area got hit pretty hard by Hurricane Harvey, there are many people that are still not in their homes, there are people in their homes that need to be repaired or reconstructed and some people living in their homes with mold still in it and the Federal Money for Hurricane Harvey that would help people with their homes has not arrived yet and they are hoping that those dollars will be here in November and when they do get the money, their intention is to quickly turn it around to give the money out to the people that need assistants and start utilizing those dollars to help repair, rebuild and to improve the people situation.

Valery Tamez, 6328 Brook Lea, 77087, (713)649-8578 (had a Translator) appeared and stated that she is a Member of the Texas Organization Project, she owns a home in Southeast Houston by the Hobby Airport, she had worked hard all of her life and been to the Office in Houston Downtown and she is here to speak on the highlights to everyone on the reality on what Hurricane Harvey Survivors are currently facing and after the Hurricane her home needed to be leveled, she spent \$3,000.00 out of her pocket and she still needs to spend \$30,000.00 out of pocket to complete her repair and she is living with her daughter because of the concerns in her home, FEMA had rejected her and after one year she still is not in her home and how much more time do they need to wait for action. Council Members Stardig, Davis, Martin, Le, Gallegos, Laster, Knox, Robinson and Kubosh absent.

Mayor Turner stated to Ms. Tamez that he is going to have Director Tom McCasland and the people from the Department of Housing and Community Development to meet with TOP and other Organizations that are out working in many of these communities to try to give a timeline, maybe to tell where the resources are and explain what they are waiting on.

Delores Torres, 2404 Caroline St., 77004, (832)998-0269 appeared and stated `that she is Harvey storm survivor and a TOP Member, it's been a year later that has left devastation for her and her family and them being homeless and the aftermath of Harvey has left a black growing mold in the floors and the sheet rock, CDC has claimed it toxic and contaminated and the work that has been done has to be redone, the CDC and the Public Adjusters have reported to her insurance. Council Members Stardig, Davis, Martin, Le, Gallegos, Laster, Knox, Robinson, Kubosh and Edwards absent.

Mayor Turner advised Ms. Torres that they are going to do everything that they can to work on her behalf and so many others to get the help that they need as quickly as possible and that they will not leave her or anyone else behind.

Adriana Vasquez, 8700 Hillcroft, 77063, (713)927-5908 (had a Translator) appeared and stated that she is a Member of TOP and she came to tell her story as a tenant and Harvey survivor, the complex was flooded and the water entered into her apartment and causing much damage, days after Harvey and she went to report all the damages without having any type of resolution from the Administration and she has Ashima, it was a night mare to live with mold all the time, having nowhere else to go was to clean her apartment daily with vinegar and baking soda so it would not affected her health, she has never stopped paying the rent and the administration told her that her only option was to relocate to another apartment and the cost was much more, it was \$300.00 more and she could not pay and she had no choice to leave those apartments and break her lease and after a year from Harvey, she is still scared about another disaster is going to happen again with no help from her landlords and her question today is what are they going to do to address that issue. Council Members Stardig, Davis, Martin, Le, Gallegos, Laster, Knox, Robinson, Kubosh and Edwards absent.

Alesia Horton, no address, (713)459-8231 appeared and stated that she is a Security Officer for the City of Houston and been in the Security Industry for 7 years and been in the City of Houston Contract for 3 years now and she would like to thank Mayor Turner and Council Members for listening to her fellow Officers for the new request for the proposal for Security for the City of Houston and the people who protect their building deserve to live with respect and this is why she believes that the City of Houston should only do business with responsible services contractors as they review bids for companies to provide services in their community, responsible contractors provide good wage, quality training, stability and employment and benefits that enable service workers to build their lives and to provide for their families and contribute to their community, that the company has a proven track record of transparency about labor laws violations and it means that a company retains the men and women correctly protecting the City buildings and a company that respects the employee rights and making working environments improvements, she thinks that the City of Houston can and should set the example for other local Governments behind contractors and contractors for security. Council Members Stardig, Davis, Martin, Le, Laster, Gallegos, Knox and Edwards absent.

Angel Flores, 8214 Tilgham St., 77029, (708)945-0182 (had a Translator) appeared and stated that he works as a Janitor for TranStar Houston and he worked at TranStar during Hurricane Harvey, he worked for 34 days and as all of them remember it was a very busy place, he is sharing his story with Council because he does not want what happen to him and his wife, to happen to any of his Co-Workers that work for the City and too many people have had their wages stolen last year and he knows several people and those people had to file claims with the Inspector General and are still waiting for their money, he thinks it is important to point out if they had a Union that this wages theft would not have happen and if his Co-Workers were able to agree with their employers about fair wages and benefits, he believes that worker employees by the City's

Contractors and Sub-Contractors should be able to exercise the right without fear or intimidation and join together through a fair process to choose, Houston should only hire responsible Contractors to provide these services to their Public buildings and as the City reviews Bids of the Janitorial Contracts for many of our Public building and he urges Council consider each Companies approach to staffing and workers' rights. Council Members Stardig, Davis, Martin, Le, Gallegos, Laster, Knox and Edwards absent.

Deborah Elaine Allen, Post Office Box 263252, 77027, (713)264-0127 appeared and expressed her personal opinion about Police Brutality. Mayor Turner, Council Members Stardig, Davis, Martin, Le, Gallegos, Laster, Knox and Edwards absent. Mayor Pro Tem Cohen presiding.

Samson Harper, 5825 Cobalt St., 77016, (281)590-5095 appeared and stated that he lives on the Northeast side of Houston and it is sad everything Harvey did not do on the North Side of Houston, he lives on Cobalt, he knows that there is a justice between poor and rich and that is what he is looking at, on his street they are bring in containers and whoever is the Council Member for this area, he wants them to hear this, these railroad containers, the outlaw trailers when it was annex in but they are bring in containers that they are putting in lights and living in them, so why can they not bring back the trailers, there is no attention that is given to Northeast Houston, when they came by to up trash the other day and the machine broke down, the trash is still on the streets and they will not pick the trash up until October, he does not think that this kind of stuff happens in San Felipe or Kingwood or Westheimer, he volunteers in Kingwood at the Hospital and he knows what is out there, they are not doing them right in Northeast side of Houston and it has nothing to do with Harvey. Council Members Stardig, Davis, Martin, Le, Travis, Gallegos and Edwards absent.

Sharon Yasin, 7225 Bellerive, 77036, (512)822-6055 appeared and stated that she comes here on behalf of 765 constituents and to talk about what they have which is a Project Zip Code, she represents all the zip codes in Houston Texas and she also comes here as a Public Notice for people of color and she is here to say that they are here as poor people, there is no such thing as poor people, they are all enriched in culture, in spirit and in emotions, so what she is saying lets make Houston great, the City is only great as it is the people and if the people are not great, the City is not great but there is a such thing as poor behavior, Houston has a lot of vacant property, a lot of back tax property, no one has to stuff nowhere, no matter who they are in the community, no matter what color, no matter what religion, no matter what people and she thinks that there should be a system where the people of Houston come and partnership with the City of Houston to utilize the properties, there is an extremely high rate of diabetes and a lot of people with high blood pressure and that is because of poor diets and she came here to ask for cooperation and they want to utilize the properties that are not being used and the properties

would prosper in the communities and they are just asking for them to just let them build to open a business, build, train the youth internships to use the people in the community to learn how to do certain things, they want to give back too and again she wants to utilize the vacant properties in these zip codes and build on them and the build that do the building are the people that live in the community and use it for internship. Council Members Stardig, Davis, Martin, Le, Travis, Gallegos, Laster, Knox and Edwards absent. **NO QUORUM**

John Noflin, 129036 Brent Rock Dr., 77082, (832)208-1498 had reserved time to speak but was not present when his name was called. Council Members Stardig, Davis, Martin, Le, Travis, Gallegos, Laster, Knox and Edwards absent. **NO QUORUM**

Amanda Luna, no address, no phone, appeared and stated that she is here to speak about the homeless but the homeless not regarding the Hurricane, she speaking about the homeless that is just due to life like herself, she had a divorce and since then she kept falling and falling, she wants to start off with that she is a spoke person for the homeless, she wanted to use a few abandon properties that she have been seeing for the past few years and these properties can be used for the homeless, one of the properties are the old Sears building on Main Street, property number two is at 4203 Fannin Street which is across the street and that could be used as a homeless documentation help center for only the homeless and property number three which is across the street from that building 1017 South Faninn which she thinks it would be a great venue for feeding the homeless and she thinks that Council is thinks how they are going to hire tons of people to run these facilities and she came up the idea that people that live in the shelter with no physicals disabilities could volunteer to work, until they are able to get all the documents they need to seek paying employment and she has been calling Government funded properties asking them how can she get into them and they told her that they have to pay \$25.00 or more to pay for an application and of they are homeless how can they come up with the \$25.00 dollars for an application fee to see if they can qualify. Council Members Stardig, Davis, Martin, Le, Travis, Gallegos, Laster, Knox and Edwards absent. NO QUORUM

Mayor Turner stated to Ms. Luna that he is not aware of the \$25.00 fee and if there is anyone who is homeless especially if their financial situation has changed or if they have other issues, they are more than willing to work with them and help them get permanent housing or temporary housing and he requested for her to speak with Mr. Marc Eichenbaum and Sean Quitzau who works directly with Mr. Eichenbaum and they can tell that this is her passion and they are willing to help her.

Carol Baker, no address, no phone, appeared and stated that the rain has gone but the storm is not over and she is talking about Hurricane Harvey, she was here June the 8th to speak to Council and the Mayor Office in regard to the homelessness because she was homeless before the storm and was effected by the storm and then homeless after the storm and presently she is in a hotel and the number one answer that she gets when she calls 211 and it seems most of the places, the organizations and nonprofit in the City of Houston that are dealing with disaster relief they believe that 211 is the answer which it is not and she looked on their website, she noticed that they have 107 disaster services on their website and they even have option about Christmas baskets for the disaster victims and that tells her that the resources are outdated and many of the Organizations that they refer them too are no longer assisting or does not exist even United Way their information is not accurate and they both need to be updated, she had spoken to Council Member Mike Laster at Blakeley Ripley in July or August and CDBG was doing something over there regarding landlord using taking advantage of people that have been displace by Hurricane

Harvey and then she called Council Member Laster Office and did not get a return call, the City of Houston needs to consider hotel vouchers for those who are still displaced because it is hard to find vouchers from agencies that will assist them and most of the agencies that ae assisting people are assisting people that are repairing their homes which there is nothing wrong with that but what about the others and a new count need to be taken on who are still battling the storm. Mayor Turner, Council Members Stardig, Boykins, Martin, Le, Travis, Gallegos, Laster, Knox, Robinson and Edwards absent. Mayor Pro Tem Cohen presiding. **NO QUORUM**

Mayor Pro Tem Cohen stated to Ms. Baker that her suggestion is to speak with Rene Ruiz and he is with the Mayor's Citizens Assistance Office he maybe able to give you guideness on the next step.

Joe Richardson, 6101 Bobby Burns, 77028, (713)818-5822 appeared and stated that since the Mayor is not here, is there any way to get the Mayor to hear this that at 6314 Bobby Burns there is a very, very filthy place and out of this place comes a man with unkept hair and he stares at peoples yard looking and he is a known thief, a drug user and if this house was destroyed this neighborhood would be safer, the doors are missing, windows are gone and he came here today to say that this house is health hazard on the ground and he does not need to be bothered with this dope head, he has been burglarized twice, August of 2006 and May of 2017; also on Bobby Burns Street there is over grown weeds and there are properties that have violations notices, he is requesting protection and they have come to his house only twice and that is when he was burglarized, no finger prints were taken and he does not tell the Police how to do their job and since this house is an eye sore and health hazard and if it was torn down maybe this man would leave. Mayor Turner, Council Members Stardig, Davis, Boykins, Martin, Gallegos, Laster and Edwards absent. Mayor Pro Tem Cohen presiding.

Upon questions of Council Member Castex-Tatum Mr. Richardson advised if that house is a vacant house that he is speaking of with the man living in it and they maybe able to report it as a Dangerous building which is with the Department of Neighborhoods.

Mayor Pro Tem Cohen asked him if he has contacted his Council Member Office and he advised her that he would not waste his time and she advised him that he should give it another shot because Council Member Davis is very responsive Council Member and his is passionate about the things that he is speaking about today and also Sergeant Juan Perales is present and if he talks to him about his concerns of safety but she strongly advises for him to contact his Council Member who can work with him in the Department of Neighborhoods and see what they can do with the issue.

Thomas Wang, no address, (832)818-0806 appeared and stated that he is here to speak on the Mid-Town Redevelopment Authority Plan on developing 2 new projects on Emancipation and Saint Charles Boulevard and this particular project is a 52,000 square feet office building that is using Affordable Housing money and under their CCPI Plan his does not understand but the building is not an affordable house and the other project next to it is a 20 story housing unit and both combined they are estimated at \$23 million and they do not know how they fund it and there is little information, regarding this project but the little information they have found is that they will be issuing a bonds from the Midtown Redevelopment Authority to fund this \$23 million-dollar project and there is no community engagement. Mayor Turner, Council Members Stardig, Davis, Boykins, Martin, Gallegos, Laster and Edwards absent. Mayor Pro Tem Cohen presiding.

Council Member Knox questioned Mr. Wang.

Mayor Turner stated that of course this is a Labor Day weekend and they want be mindful to all of the employees, the people that are out here working every single day, they have talked about work place safety which is critically important, the wages that people make, they have countless people come to speak on Tuesday about Wages Theft and they are concerned about all the employees from the Janitor to the Contractors Companies and this weekend is Labor Day weekend and they want them to be mindful and Houston Texans will be playing the team from the Northside of the City which is the Dallas Cowboys, go Texans and continue to root for the Astros.

Members of Council questioned and commented on Mayor Turner's comments.

Mayor Turner further stated that he wanted to acknowledge what happen on Saturday on the Bond Vote, 86% is huge especially on a \$2.5 billion dollar package with a Tax increase, it point outs that people will support something they feel like they need and passing it, is one thing but executing is another because people have expectations and now the hard part comes in they have to move with the greatest degree of urgency to move with those projects that will have mitigating influence on the risk of flooding and he knows that the County voted out about 16 projects yesterday and he looks forward to collaborate with them and it shows that they are trying to address people's needs and now we have to do their part and live up to the reputation that the City has made.
