At 9:08 a.m. Mayor Turner called the meeting to order and stated they would start with the Monthly Financial Report. Council Members Stardig, Davis, Cohen, Le, Travis, Gallegos and Robinson absent.

REPORT FROM CITY CONTROLLER AND THE CITY ADMINISTRATION REGARDING THE CURRENT FINANCIAL STATUS OF THE CITY including, but not limited to, a revenue, expenditure and encumbrance report for the General Fund, all special revenue funds and all enterprise funds, a report on the status of bond funds and a Quarterly Investment Report by the City Controller was presented. City Controller Chris Brown, and Director of Finance Department Tantri Emo, reviewed the Monthly Operation and Financial Report; copies of which are on file in the City Secretary's office for review. #### **MAYOR'S REPORT**

Mayor Turner started with a brief report stating that March is Women's History Month, established by Congress in 1981. Mayor Turner expressed that we have a number of women that are making history each and every day. He wanted to give a shout out to all of the women including the women on City Council. He also wanted to remind people that today is an important da for many Houston area youth. The City will be accepting applications online for hirehoustontx.org for summer jobs for youth ages 16-24. He then stated that Spring Break is next week and asked that everyone be safe. And also that the next City Council meeting will be held on next week.

Mayor Turner reminded everyone that March is also Colon Cancer Awareness Month. It was acknowledged by lighting the outside of the City Hall building in blue. He encouraged everyone to get tested.

Mayor Turner wanted to give a special congratulations to Kristina Morales who, on yesterday, became a State Representative.

Council Member Boykins stated that last week he visited the Fire Training Academy for the swearing in of Cadet Germane Luna and while there, he heard some surprisingly horrible stories

from some of the fire cadets about living in limbo and having difficulty paying their bills. There are 68 fire cadets waiting to be sworn in, some of which have been waiting as long as 6 months. They need to be sworn today and be able to move forward. He also asked, "why are they waiting?" The City is continuously paying out millions in overtime to current firefighters that are active to fill in the gap. Council Member Boykins asked the Mayor, "why are there budgetary issues concerning the fire cadets, yet the police cadets are being sworn in as they become available?" He stated he sent this question to the Mayor, in writing, on March 1, 2019. Which he then stated from today and going forward, he was going to tag every single item on the Agenda excluding items 39 and 41 until these cadets are seated.

Mayor Turner stated that he looks forward in discussing Proposition B starting with Council Members tomorrow.
