The Houston City Council reconvened at 9:00 a.m., Wednesday, May 1, 2019, Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Marta Castex-Tatum, Mike Knox, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Ronald Lewis, City Attorney, Marta Crinejo, Agenda Director and Stella Ortega, Agenda Office present. Council Member David Robinson absent on personal business.

At 9:07 a.m. Mayor Turner called the meeting to order and move to the Mayor's Report. Council Members Stardig, Davis, Boykins, Le, Travis and Cisneros absent.

MAYOR'S REPORT

Mayor Turner stated that Council Member Laster is leaving at 10:00 a.m. for the Funeral for Stuart and Angie Kensinger. Mayor Turner requested a moment of silence for their family and friends. Now, he wanted to give a brief Mayor's Report which he wants to focus on one item today to bring it to their attention. House Bill 2846 that's now in the Senate and was carried by Senator Joan Huffman. This is the Bill that pertains to the Allen Creek reservoir. Back in 1999, Houston Lighting and Power had the permit to Allen Creek, and they were going to use the creek to cool off a nuclear power plant which they never did. The permit expired and it was reactivated through the Legislation, it was reactivated and the Brazos Alliance, which consists of Missouri City, Richmond, Sugar Land, the Brazos River authorities and all the entities and they asked the City of Houston to take the lead in obtaining the permit for Allen's Creek and to construct the Allen Creek reservoir and the City of Houston did take a lead. As a result of that, the Brazos River Authority and the City of Houston have entered

into a contract along with the Texas Water Development Board and that is where the City of Houston would get 70% interest from the water rights to Allen Creek and Brazos River Authority would get 30%. Since 1999 up to date, the City of Houston had spent about \$23 million dollars. Now, up to this date, Water Rights are highly sought out and people want them and during the Legislation Session, the Bravos River Authority offered the City of Houston \$5 million dollars for their Water rights and he refused, basically starting they don't sell Water Rights and with the \$5 million dollars nowhere near the value of it. Mayor Turner then stated that the question was from Chairman Lawson who comes out of the San Antonio area, that the City of Houston has not constructed Allen Creek, the previous Mayor's haven't done it and they want the Allen Creek constructed. He listens to them and they made a good point to him which then he wrote a letter to Chairman Lawson, saying "that the City of Houston would move forward to construct the Allen Creek reservoir, but the City of Houston will not give up the Water Rights, even after the City agreed to move forward with the construction which that was not enough. What they want is the City of Houston Water Rights and they think that the City of Houston, owning 70% of the Water Rights, is way too much. This is coming out from Austin, so they have passed the Bill out of the House. It literally takes away the City of Houston Water Rights away from Allen Creek. He would argue that is illegal and Allen Creek represents 15% of the City's Water Portfolio. For the Legislature to be talking about taking the City of Houston interest of 70%, he is going to ask everyone to contact Senator Huffman. Again, it's House Bill 2846 and include in the letter that the City of Houston needs to hold on to the Water Rights and also this would impact West Houston, Fort Bend, Sugar Land areas and Katy area. Mayor Turner stated that it's unjust taking away a person's property rights without any source of compensation for it.

Members of Council commented and questioned the Mayor about the Senate Bill 2846.
