MAYOR'S REPORT

Mayor Turner stated that of course yesterday the City of Houston experienced another Police Officer that was lost with the death of 47-year-old Sgt. Sean Rios. Mayor Turner wants everyone to lift up his family and friends. He has 4 children and two other relatives that work within HPD, we don't know all of the circumstances that surrounded what happened, he was in plain clothes in his own vehicle, on his way to start his shift at 2 o'clock when that situation occurred at I-45 close to Gulf Bank Street. Mayor Turner is requesting if anyone knows about the incident that he is referencing to, he is hoping that someone will report it. In fact, in any kind of crimes he hopes that people will report the information that they know because it's not just up to HPD, this is a community effort in addressing the crimes that are taking place.

In regard to COVID-19, the positivity rate has inched up from 6.7% to 6.9% for this week. Mayor Turner is asking people again to be mindful throughout the country, this State especially in El Paso because there are over 100,000 cases that are being reported every single day and in the United States, we have gone past 1 million cases. So, in order to keep the surge from taking place here in this City, it's important for people to mask up, engage in social distancing and exercise proper hygiene. As the Holiday seasons are approaching it just has to be different than in years before, so if family members are going to get together, he hopes family members be mindful and also limit the amount of family members. People from one State that are going to a different State for them to voluntarily isolate themselves for 14 days.

Mayor Turner stated that tomorrow is a very special day, It's Veterans Day, the City of Houston offices will be closed tomorrow, and we will be holding a special celebration to honor all who served in the Military. Due to the pandemic, for the safety of us and everyone else, this year's Veteran's Day program will be live from City Hall. The public can honor by watching the virtual program at the 23rd Annual Houston Salutes America Hero's will include a moment of silence and swearing in Ceremony for Military Recruits and more for the information is on the City of Houston website.

The Alief Neighborhood Community Center, will join Council Member Thomas and the Directors of Health, Parks and Library for the Alief Neighborhood Center groundbreaking and they have been waiting for this for over 20 years. This Center will have mixed use that will accommodate three City of Houston Facilities under one roof and Council Members are welcome to join them at 2:30 p.m. today. The Legal Department and the Business of Opportunity are doing a free virtual workshop to teach people how to do business with the City of Houston and he knows that these issues have come up in the past, so again that is why the Legal Department and OBO will be doing a free virtual workshop.
