A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, February 9, 2021 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Robert Gallegos, Karla Cisneros, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director present. Council Member Letitia Plummer absent on Personal Business.

At 2:02 p.m. Mayor Turner called the meeting to order and recognize Council Member Pollard for the Invocation and which he led the Pledge of Allegiance.

The Houston City Council reconvened at 9:00 a.m., Wednesday, February 10, 2021 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Arturo Michel, City Attorney Legal Department and Marta Crinejo, Agenda Director present. At 9:00 a.m. Mayor Turner called the Meeting of the Houston City Council to order and requested the Interim City Secretary to call the roll.

MAYOR'S REPORT

Mayor Turner stated with COVID-19 Vaccine conversation with Radio Station 97.9 The Box, Stephen Williams, Doctor Napoleon Higgins and Doctor Felicia Jordan and they were answering questions and sharing the facts. To participate you can go to 97.9 The Box Facebook page and you can be part of that conversation. He wants to continue to ask all Houstonians to participate with HPD in addressing the crime, the wave that is occurring not only in our City but the Region. HPD have their role to play but the communities also very vital role to play and with any information you have that can assist Law Enforcement in addressing these crime, in solving these crimes or preventing these crimes, he is going to ask you to provide the information either directly to HPD or if you have information about crimes that have been committed, he is asking you to provide that information to Crime Stoppers and you can give that information anonymous because it's all hands on deck. It will also help if Community Leaders will speak up and help against this crimes situation, it's important for people to hear his voice or Chief Acevedo but it's important for people to hear communities people in these neighborhoods in speaking up. He is going to be reaching out to a number of Community Leaders and Faith-Based Leaders very soon.

On Solid Waste we have a recycling program in our City but we also been noticing a large percentage of contamination and what he means by that people are putting some of everything in the green bins, that is not recyclable and that causes contamination and when that happens, we risk that whole load for being thrown out. Not able to be recyclable and he asking to please not put out like water hose in the green bins, some people have put tires in the green bin and please don't put yard waste in the green bins. Please do not treat the green bins as a second black bin. Solid Waste and others are going to be engaging with education campaign to again educate people in what goes in the green bin and what should not be placed in the green bin.

Mayor Turner stated that later on this morning we're going to be dealing with a couple of Rental Assistance Items and in case of that he will speak on those items. Between the dollars that have come through the Stimulus package between the City and the County, it's over \$150 million dollars for rental assistance and that is the largest amount that we have had during this

pandemic. We are working to allow our efforts so that we can maximize the effectiveness the impact and to lower and prevent evictions. In addition to that our State also assistance with a billion dollars, this is significant, substantial dollars out there for cash for rental assistance that can't only address evictions but people who have lost their jobs, it also can prevent people from falling into a worse financial state. Because it is taking a little more time and because there are added requirements for documentations with these dollars and what he has decided to do and what will be coming to you next week is to also approve the Ordinance that will prove a grace period on evictions through the end of March; March 31st, it align itself with CDC's requirements, the CDC's timeline but it will stay in the City of Houston to work through for the County and the City to align it self even with the State's so we really maximizing the effectiveness of these dollars. He does not think people should not be evicted when these dollars are coming in this time period because the money is there. So he is going to instruct the Legal Department to put forth for a grace period ordinance and it will be on the Agenda for next in asking you to approve a grace period on evictions that will last through March 31st and he hopes that they will approve it and he wants the JP's to know about it and the people to know about it.
