

Council Chamber, City Hall, Tuesday, September 19, 2023

A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, September 19, 2023, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Carolyn Evans-Shabazz, Dave Martin, Mary Nan Huffman, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department, and Marta Crinejo, Agenda Director, present. Council Members Abbie Kamin, Tiffany D. Thomas and Mike Knox absent on personal business.

At 1:40 p.m., Mayor Turner called the meeting to order and wanted to make a special acknowledgement and presentation.

Mayor Turner started off by stating about little over a month ago, there were about 30 of them that went to the countries of Nigeria, Côte d'Ivoire and Ghana in Africa. Council Members Castex-Tatum was on that trip, along with Council Members Cisneros and Thomas. On that trip in Ghana, they met the Ambassador of the Diaspora, Erieka Bennett, along with her sister, Dr. Toni Luck. In Ghana, they were a very gracious host to them. They talked about then opening an office here in the City of Houston. Mayor Turner asked Ambassador Bennet and Dr. Luck to stand and be recognized. We visited them a little over a month ago and they have come to Houston to visit us. In fact, they are making several stops in the United States. They will be heading to Washington D.C. with their final stop in New York City. Their goal was to come set up an office for the Diaspora for their non-profit in the United States and they wanted their first office to be in the City of Houston. He is pleased to say that working with his Chief of Staff and others that they have located their first office which will be located at 3131 Emancipation in Third Ward and in the District of Destination. Mayor Turner wanted to give them a Houston welcome and they are so honored to have them here.

Council Member Gallegos presented a proclamation to National Partnership for New Americans (NPNA) and Cities and Countries for Citizenship (CC4C) recognizing Citizenship Day. ## **MAYOR'S REPORT**

Tomorrow is the ribbon cutting for the Lynn Wyatt Square for the Performing Arts and will be open to the public with free, fun and programming for the entire family. The former Jones Plaza has been transformed into an amazing green space. He really thinks they will certainly enjoy it and he is hoping that Lynn Wyatt would very much enjoy it. Certainly, the Houston First Corporation led this development but it would not have been possible without the public/private initiative. He really wanted to thank Lynn Wyatt for her generous gift in making this happen. They will also be showing the Jones Plaza as well, so people will be going from one place to the other.

The Houston Public Library will host One Houston One Book Grand finale on Thursday night. It is an evening with Author Nicole Hannah Jones, who wrote the 1619 Project. Other authors will also be featured. One Houston One Book is a citywide reading program that promotes literacy, diversity and community conversations by encouraging Houstonians to read and discuss books with a common theme.
