Controller Hollins noted, "My goal this Women's History Month was to bring together leaders and lean on their expertise and perspectives to form a vision around increasing economic mobility – the next step is now to chart a path we can take to get there."

Hollins served as the panel's co-moderator alongside Anna Reger, Founder and CEO of FlipLok, a Houston-based manufacturer specializing in door locks and related security infrastructure to fend off active threats.
