Ron Lucey (Governor's Committee on People with Disabilities)

- Proud of great work happening in Houston
  - o Report shown identifies top 40 priorities
  - o Houston Commission on Disabilities is one of the oldest committees- over 70 years
  - o 10 Policy issues- Access, communication, criminal justice, education, emergency management, employment, housing, transportation, veterans, criminal justice system
  - o ESA/Service animal confusions: ESA is not a trained animal- making recommendation to clean up HR code
  - o 40 proposals to the legislator

- TOP ONES: Increase pay for personal care attendance, allowing family members to be paid caregivers, expanding TDA do not hire registry, increasing certified interpreters pay rate
- o Hopeful adult changing tables will be accessible at large spaces such as movies, stadiums, etc.
